APPLICATION INSTRUCTIONS FALL 2021

About the Program:

The Bachelor of Applied Science - Information Technology Application Development degree (BAS-ITAD) is an evening/hybrid program that builds on professional-technical associate degrees, such as the Associate in Applied Science-Transfer (AAS-T) degree or equivalent, for a total degree of 180 credits. A minimum of 90 credits must be completed prior to admission.

Edmonds College is accredited at the baccalaureate level by the Northwest Commission on Colleges and Universities and the program is approved by the Washington State Board for Community and Technical Colleges.

Before You Apply:

Prior to starting the BAS-ITAD program, students need to:

- Complete an Associate in Applied Science-Transfer (AAS-T) or equivalent degree* in one of the following areas, with a minimum GPA of 2.0:
 - Computer Information Systems (CIS)
 - Web Development and Cloud Computing
 - Computer Science
- Complete the following prerequisite courses with a minimum grade of 2.5 in each course:
 - ENGL 101 English Composition
 - MATH 141 PreCalculus I
 - Natural Science with Lab
 - CS 143 Computer Science III Java (or equivalent)
- Earn a minimum cumulative 2.5 GPA and a minimum grade of 2.0 in core courses of the AAS-T, or equivalent degree.

*Students without an AAS-T degree are encouraged to consult with the <u>program manager</u> to determine equivalency prior to applying. Students can apply before completing their degree, as long as they are scheduled to complete their AAS-T degree, or equivalent, by the end of summer 2021.

Application Checklist:

- If you are new to Edmonds College, apply for admission to Edmonds College.
- Complete the application for the BAS-ITAD degree program.
- Attach your official transcripts showing a minimum 2.5 GPA in pre-requisite courses and minimum overall GPA of 2.0 in a two-year degree.
- Write a 1-2 page personal statement (view instructions below).
- Attach a resume that describes relevant work and skills and includes internships, work study, and volunteering activities.
- Pay the \$25 application fee

Personal Statement:

This writing sample will provide the Admissions Committee with the opportunity to learn more about your education and career goals. It is an important part of the application process. Please write a statement of 1- to 2- double-spaced pages addressing the following:

- Personal and professional goals and how this degree relates to those goals.
- Work experience or specific attributes that relate to the program.
- Challenges or hardships that have been overcome in pursuing educational or work goals.

Resume:

Attach a resume that describes relevant work and skills and includes relevant internships, work study, and volunteering activities.

Non-Refundable BAS-ITAD Application Fee:

Please pay the \$25.00 non-refundable application fee to the Cashier's Office. Inform them that you are paying for the \$25.00 BAS-ITAD application fee.

Due to the college closure, the fee may be paid online after your application is received. The amount will be added to your account after the ITAD department notifies the Cashier's Office of your application.

Activating and Receiving Your ctcLink ID:

Starting February 16th, 2021, you need to activate your ctcLink account and receive your ctcLink ID which will replace your current nine-digit SID number. Use the dropdown menu of "*ID Type" to select "*SID (old)" and enter all appropriate information. Submit and be sure to save your ctcLink ID in a safe place.
